

AN ACT

Amending Section 10 of Article VI of the Chuk State Constitution, providing for the referendum to the people of Chuk for the approval of the amendments, providing for its effectivity and for other purposes.

Be It Enacted by the Chuk State Legislature:

Section 1. Amendment. Section 10 of Article VI of the Chuk State Constitution is hereby amended to read as follows:

Section 10. The powers, functions, and responsibilities of all executive departments shall be prescribed by statute."

Section 2. Effectivity. Pursuant to Section 2, Article XIV of the Chuk State Constitution, this amendment shall be effective upon the approval of the people in the next general election by a majority of the votes cast on this amendment and by majority votes of all registered voters.

Section 3. Effective Date. This Act shall take effect upon approval by the Governor or upon its becoming law without such approval.


