

FIRST REGULAR SESSION, APRIL, 2011

ACT NO: 11-08

AN ACT

To authorize the Governor of Chuuk State to procure a loan in the amount of \$350,000 from any banking institution in the Federated States of Micronesia, to earmark the said loan proceeds for the land acquisition for the administration and legislative complex, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1 Section 1. Authorization. The Governor of Chuuk State is hereby authorized to
2 procure a loan in the principal amount of \$350,000 excluding financing costs from any
3 banking institution in the Federated States of Micronesia for the purpose of funding the
4 acquisition of the land where the administration and legislative complex will be built.

5 Section 2. Repayment. The loan shall be paid within five (5) years. The loan shall
6 be paid from the following sources:


- 7 a) Departure fees beginning the FY 2012; and/or
8 b) The dividends from the FSM Bank shares of stocks owned by Chuuk State.

9 Section 3. Appropriation for repayment. Notwithstanding any law to the contrary,
10 departure fees is hereby appropriated starting FY 2012, and dividends from the FSM
11 Bank shares of stocks is also appropriated for the payment of the above loan including
12 interests therein.


13 Section 4. Appropriation. The amount of \$350,000 obtained and as loan proceeds
14 is hereby earmarked and appropriated for the acquisition of the lands where the future
15 administration and legislative complex will be built. Any balance of the \$350,000 after
16 full payment of the land acquisition shall be paid back to the loan. The Governor shall be
17 the allottee of the funds.

18 Section 5. Reporting. The Governor, or his designee, shall submit a written report
19 to the Legislature on or before December 30, 2011, which shall:
20 a) Provide for the full disclosure of the status of the loan application;
21 b) Provide for the statements of accounts for which the loan proceeds was
22 applied.

1 Section 6. Effective Date. This Act shall take effect upon approval by the
2 Governor, or upon its becoming law without such approval.






