AN ACT


To amend Section 2 of Chuuk State Law No. 8-07-06, also known as the “Public Service Commission Act of 2007” by exempting the Department of Education and its employees from the Public Service Commission and place them under the control and management of the Board of Education in accordance with Article X, Sections 2 and 4 of the Chuuk State Constitution, Section 2 of CSL No. 191-15, also known as the Chuuk State Board of Education Act of 1991, and for other purposes.


Be it enacted by the Chuuk State Legislature:

1           Section 1. Amendment. Section 2 of Chuuk State Law No. 8-07-06 also known  
2 as the “Public Service Commission Act of 2007” is hereby amended to read as follows:


3           “Section 2. Public Service Commission. There is hereby created an  
4 independent public service commission to be known as “Public Service  
5 Commission”. It shall be responsible to establish and maintain a system of  
6 personnel administration based on merit principles and generally accepted  
7 methods governing the classification of positions and the employment, conduct  
8 promotion and termination of public officials and employees, except for the  
9 Department of Education and its employees whose system of personnel  
10 administration and management shall be under the control of the Board of  
11 Education in accordance with Article X, Sections 2 and 4 of the Chuuk State  
12 Constitution and Section 2 of the Chuuk State Board of Education Act of 1991.  
13 The Department of Education shall acquire control over the files, records, and  
14 other relevant documents of its employees from the Public Service Commission  
15 and complete the transfer of such files, records and documents within 30 days of  
16 the effective date of this Act. Within 90 days after the effective date of this Act,  
17 the Board of Education shall establish a personnel administrative system, rules  
18 and regulations for employees of the Department of Education. Until such time as  
19 the Department of Education establishes a personnel administrative system it shall  
20 utilize the Public Service Commission regulations to administer its personnel  
21 system.”


22           Section 2. Effective Date. This Act shall take effect upon approval of the  
23 Governor or upon its becoming law without such approval.


