ACT NO. 12-11

AN ACT

To enact a new Chuuk State Law prohibiting the taking, possession, collecting, selling, offer to sell, buy, transport, export, import, distribute, trading of shark fins, regardless of where captured, brought, transported from, bartered for, traded, or obtain and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Findings. The Chuuk State Legislature finds that Sharks are one of the top
2 predators in the marine food chain and play an important role in our ocean's ecosystem. Sharks
3 have characteristics that make them more vulnerable to overfishing than most fish, and data from
4 state, federal, and international agencies show a decline in the shark population worldwide.
5 Unlike other fish species, most sharks do not reach sexual maturity until seven to twelve years
6 of age and ten only give birth to a small litter of young. Thus sharks cannot rebuild their
7 populations quickly once they are over-fished.

8 The practice of shark finning, where a shark is caught, the fin is cut off, and the shark is
9 returned to the water, causes tens of millions of sharks to die a slow death each year, some sharks
10 starve to death, others are slowly eaten by other fish, and some drown because most sharks need
11 to deep moving to force water through their gills for oxygen. Sharks are an essential element of
12 the ocean's ecosystem, and by reducing the demand of shark fins. Chuuk State can help ensure
13 that sharks will not become extinct.

14 The Legislature also finds that the taking of sharks for subsistence purposes is a
15 longstanding tradition. Moreover, the Legislature recognizes that incident catching of sharks can
16 be avoidable.

17 Section 2. Shark Finning Prohibited, Penalty, Enforcement.

18 (a) For the purpose of this Act Shark fins are the raw or dried fin tail of a shark.
19 (b) It shall be unlawful for any person to possess, sell, collect, offer for sale, buy,
20 transport, export, import, trade, or distribute shark fins in Chuuk State regardless of
21 where captured, bought, transported from, bartered for, traded, or obtained.
22 (c) Notwithstanding the provisions of subsection (b) any person with a valid license
23 or permit issued by the Department of Marine Resources to conduct research and who
24 possesses shark fins shall not be subject to the penalties in this Act in accordance with

1 the regulations and the following conditions:

2 1. An administrative fee of not less than \$500 which shall be paid to the Tax and
3 Revenue Section;

4 2. The permit shall be limited to a given or specific area;

5 3. The permit shall be valid only for thirty (30) days which may be renewed but
6 shall not exceed 90 days in any given year;

7 4. The permit shall authorize any Marine Enforcement Officer of the Department
8 of Public Safety to board and inspect the vessel conducting the research at any time
9 without notice;

10 5. The permit shall not allow any intentional by-catch of other species.

11 Intentional is always presumed if more than other marine species, other than shark, is
12 caught;

13 6. The permit may impose any additional terms and condition consistent with this
14 Act or the regulations promulgated pursuant to this Act.

15 (d) Notwithstanding the provisions of subsection (b) of a shark for subsistence purpose,
16 noncommercial only shall not be subject to penalties in this Act.

17 (e) A catch limit on all or certain species of sharks in subsection (c) and (d) may be
18 imposed by regulations promulgated by the Department of Marine Resources.

19 (f) The Department of Marine Resources or the Department of the Public Safety shall
20 have jurisdiction to enforce, investigate and make referrals to the office of the Attorney
21 General. The Attorney General may pursue either civic or criminal action to enforce this
22 Act. Any person found in violation of this Act shall be punishable by imprisonment for a
23 period not to exceed 10 years and the assessing of a fine not less than \$25,000 and not
24 more than \$200,000 per violation.

25 (g) Any Shark that is inadvertently caught or captured, except as provided by subsections
26 (c) and (d), shall be immediately released, whether the shark is dead or alive. No shark or
27 any parts thereof shall be retained even caught as by-catch.

28 (h) Each Shark fin removed from the body shall constitute a separate prosecutable
29 offense.

30 (i) Any individual shark, or parts of the same confiscated shall be destroyed by

1 incineration, dumping at sea or any other appropriate means, subject to the requirements
 2 of subsection (l) below.

3 (j) If any provision of this Act or its application to any person or circumstance is found
 4 to be invalid or contrary to law, such invalidity shall not affect other provisions of
 5 application, and to this end the provisions of this law are severable.

6 (k) Any items seized pursuant to enforcement of this Act and its regulation shall be held
 7 by the Department of Marine Resources pending disposition of civil or criminal
 8 proceeding, or the institution of an action in rem for the forfeiture of such item, except
 9 that after Notice and Public Hearing the Department of Marine Resources, in lieu of
 10 holding such item, permit and the owner, consignee, or other responsible person to post a
 11 bond or other surety satisfactory to the Department of Marine Resources.


12 (l) The Department of Marine Resources may adopt rule; and regulations pursuant to the
 13 administrative procedures act necessary for the purpose of this Act.

14 Section 3. Effective Date. This Act shall become law upon approval by the Governor or
 15 upon its becoming law without such approval.


