AN ACT

To amend Section 4 B&C of CSL 11-11-10 to provide for the selection and appointment of members of the Board of Directors by the mayors of the municipalities in the Mortlock Islands, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1       Section 1. Amendment. Section 4 B&C of CSL 11-11-10, is hereby amended as follows:

2              "Section 4. Board of Directors.

3                  A. Establishment. There shall be a Board of Directors of the Mortlock Islands  
4                      Development Authority which shall have general management and control over the  
5                      authority.

6                  B. Composition. The Board shall be composed of 13 members: One (1) from  
7                      each of the eleven municipalities in the region to be selected and appointed by the  
8                      mayor each such municipality; the FSM Congressman from the Mortlocks Region; and a  
9                      Representative to be appointed by the Governor of the State of Chuuk if any, to serve as  
10                      ex-officio member to only render technical advice to the body and shall not serve as an  
11                      officer of the Board"

12                  C. Terms of Office. Terms of office of those members appointed by the mayors  
13                      of the municipalities shall end upon the conclusion of the term of the mayor who  
14                      appointed that member, except that the initial terms of office and filling of vacancies  
15                      shall be as provided in this Act. The term of office for the first Board shall commence on  
16                      the day of the first meeting of the Board."

17           Section 2. Severability. If any portion of the Act is held to be unconstitutional or  
18              otherwise unenforceable by a Court of competent jurisdiction, then the remaining portion of this  
19              Act shall be deemed severable and shall remain in full force and effect.


20           Section 3. Effective Date. This Act shall become effective upon approval by the
