## AN ACT

Appropriating the \$500,000 Chuuk State Operations Supplement Fund from the FSM for Fiscal Year 2016 pursuant to FSM Public Law 19-71 Section 5, and for other purposes.

## BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1	Section 1. <u>Appropriation</u> . The \$500,000 Chuuk State FY'16 operations supplemental
2	fund provided by FSM Public Law 19-71 Section 5 is hereby appropriated for the specific uses:

20	Section 2. Allotment, Management and Reporting. The Governor is the allottee of the
21	\$500,000 as provided in the FSM Public Law. As such, in addition to his allottee responsibilities
22	under the public law, he shall also manage the funds herein appropriated in accordance with all
23	applicable state laws, specifically including the Chuuk State Financial Management Act. He shall
24	ensure that all the funds are expended and obligated as provided herein, and shall report to the
25	Legislature on the full and complete expenditures of the funds; provided that the funds

- appropriated for the State Youth and Constitution Day in Subsection (5) above, no part of that
- fund shall be used for recreation officials' allowances or stipend or expenses.
- Section 3. <u>Effective Date.</u> This Act shall become law upon approval by the Governor, or
- 4 upon its becoming law without such approval.
