

AN ACT

To amend Section 2 of Chuuk State Law No. 190-07, as amended by CSL No. 2-94-10 and further amended by CSL No. 7-03-05, to establish the Project Management Office, prescribe its responsibilities, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Amendment. Section 2 of Chuuk State Law No. 190-07, as amended by
2 CSL No. 2-94-10, and further amended by CSL No. 7-03-05, is hereby amended to read as
3 follows:

4 "Section 2. Executive Organization. In addition to the Office of the Governor and the
5 Office of the Lieutenant Governor, the Executive Branch of the Chuuk State Government
6 shall consist of the following departments and offices:

- 7 1. Department of Health Services
- 8 2. Department of Education
- 9 3. Department of Transportation
- 10 4. Department of Marine Resources
- 11 5. Department of Agriculture
- 12 6. Department of Administrative Services
- 13 7. Department of Public Safety
- 14 8. Office of the Attorney General
- 15 9. Project Management Office

16 Section 2. Amendment. A new Section 10 of CSL No. 7-03-05 is hereby created to
17 read as follows:


18 "Section 10. Project Management Office (PMO). The PMO shall be
19 responsible for the implementation and management of all infrastructure projects funded by
20 the Infrastructure Development Grant of the Compact of Free Association, as amended, and
21 approved by the Chuuk State Infrastructure Project Implementation Committee (IPIC) as
22 identified by the Chuuk State Infrastructure Development Plan (IDP) which has been
23 approved by the FSM and the Joint Economic Management Committee (JEMCO). The

PMO shall be responsible for such projects management and implementation from initial project planning, through design, construction, monitoring and final inspection. The core professional staff of the PMO shall consist of a project manager, a contracting officer, a US certified resident engineer and an inspector. The PMO may contract the services of other engineers of technical specialist as may be needed from time to time. The project manager shall supervise the daily activities of the PMO and serve as local counterpart for the national Project Management Unit. The project manager shall maintain close coordination with the state Infrastructure Project Implementation Committee (IPIC) and the Chief of the Division of Planning and Statistics regarding all Compact funded state projects.”




