Section 1. Amendment. Section 9 of C.S.L. No. 8-06-07 as amended by Section 7 of CSL  $_{
m No.}$  8-06-17 is amended to read as follows:

"Section 9. Operating Expenses of Other Programs. The sum of \$1,795,838, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the State for the fiscal year ending September 30, 2007, for the purpose of funding the operational expenses of the Other State Programs. Provided, however, that the funds herein appropriated and earmarked for the PSCP Oversight and Monitoring shall be expended and administered in accordance with the Public Sector Capacity Building Grant's terms and conditions. The Governor shall be the allottee of these funds. These funds shall be apportioned as follows:
