APPROPRIATING THE SUM OF FIFTY THOUSAND DOLLARS (\$50,000.00) OUT OF THE GENERAL FUND OF THE TRUK DISTRICT LEGISLATURE, NOT OTHERWISE APPROPRIATED, FOR THE PURPOSE OF PROVIDING GRANT-IN-AID FUMPS TO MUNICIPALITIES IN TRUK DISTRICT, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Appropriation. There is hereby appropriated the sum of fifty thousand dollars (\$50,000) out of the General Fund of the Truk District Legislature, not otherwise appropriated, for the purpose of providing grants-in-aid to municipalities in Truk District. Such funds shall be allocated as follows:

Section 2. <u>Disqualification</u>. Any municipality which falls under any of the following categories is hereby disqualified from receiving the funds appropriated hereinbefore:

- (a) misuse of the previous grant-in-aid funds;
- (b) Failure to complete a project due to laziness of the people of a municipality;
- (c) failure to give a progress report on a project;
- (d) use of materials that are purchased for a given project on another project.

Section 3. Administration. The funds appropriated hereunder shall be administered by the Community Development Office or such other person are persons who are authorized by law. When a municipality is disqualified use its share of the fund appropriated pursuant to this Act by virtue of Section 2 of the same, its allocation may be utilized by other municipalities which so request under such conditions as the Community Development office may provide.

Section 4. <u>Responsibility</u>. The Community Development Office shall be responsible for the funds appropriated hereunder in accordance with the previsions set forth in Public Law 15-13.

Section 5. <u>Application</u>. All applications for the Truk District Legislature grant-in-aid funds shall be filed with the Community Development Officer no later than March 31, 1972.

Section 6. <u>Reversion</u>. All funds not used or encumbered at the end of fiscal year 1972 shall be reverted to the General Fund of the Truk District Legislature.

Section 7. Effective Date. This Act shall take effect upon the approval of the District Administrator, Truk, or upon its becoming law without such approval.
