APPROPRIATING THE SUM OF SEVEN HUNDRED TWENTY BOLLARS (\$720.00) OUT OF THE GLAENAL FUND OF THE TRUK DISTRICT LEGISLATURE, NOT OTHERWISE APPROPRIATED, FOR THE PURPOSE OF PROVIDING ALLOHANCES TO THE CERTIFIED MIDNIVES WHO MAKE SO PLOTED THE OEO MIDNIFERY TRAINING PROGRAM AND ARE NOT BEING PAID BY THE MEDITARY GOVERNMENT, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. <u>Appropriation</u>. There is hereby appropriated out of the General Fund of the Truk District Legislature, not otherwise appropriated, the sum of seven hundred twenty dollars (\$720.00) for the purpose of providing allowance to certified midwives who have completed the OEO classifiery training program and who are not being paid by the Trust Territory Sevenment.

Section 2. Employment Policies. There shall be twelve midwives provided allowances under this act. These midwives shall be those who are not provided allowance by the Trust Territory Government. This act shall provide allowance commencing July 1, 1971, and ending December 31, 1971, and ending December 31,

Section 3. Allowance. Allowance for each midwife shall be set ten dollars (\$10.00) per month during the term of this appropriation.

Section 5. Reverter. Any fund unspent or unencumbered at the end of Fiscal Year 1972 shall revert to the General Fund of the Truk District Legislature.

Section 6. Effective Date. This act shall take effect upon the approval of the District Administrator or upon its becoming law without such approval.
