AN ACT

FOR THE INCORPORATION INTO THE TRUK DISTRICT CODE OF LAWS OF A GENERAL AND PERMANENT NATURE PASSED BY THE TWENTY-FIRST REGULAR SESSION OF THE TRUK DISTRICT LEGISLATURE; AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. <u>Purpose:</u> The purpose of this Act is to provide for the incorporation into the Truk District Code of those laws of a general and permanent nature passed by the Twenty-First Regular Session of the Truk District Legislature.

Such technical corrections shall include, but not be limited to, the following:

- (1) Preparation of revised tables of contents for the Truk District Code and the subdivisions thereof;
- (2) Preparation of part and chapter headings for parts and chapters added by this Act;
- (3) Substitution of the word "Chapter" for the word "Act" whenever necessary
- (4) Substitution of Truk District Code numbers for Truk
 District Law section numbers for Truk District Law section
 numbers in the text of the Truk District Code;
- (5) Correction of obvious typographical errors; and
- (6) reparation of additional cross-references and index entries as required by the addition of new material to the Truk District Code.
