AN ACT

APPROPRIATING THE SUM OF FIFTY THOUSAND (\$50,000.00) DOLLARS OUT OF THE GENERAL FUND OF THE TRUK DISTRICT LEGISLATURE, NOT OTHERWISE APPROPRIATED, FOR THE PURPOSE OF PROVIDING GRANT-IN-AID FUNDS TO MUNICIPALITIES IN TRUK DISTRICT, PURSUANT TO SECTIONS 101-107 OF TITLE 23 OF THE TRUK DISTRICT CODE (TRUK DISTRICT LAW 15-13); AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Appropriation: There is hereby appropriated the sum of fifty-thousand (\$50,000.00) dollars out of the General Fund of the Truk District Legislature, not otherwise appropriated, for the purpose of providing grants-in-aid to municipalities in Truk District, pursuant to sections 101-107 of Title 23 of the Truk District Code (Truk District Law 15-13).

Section 2. Disqualification. Any municipality which falls under any of the following categories is hereby disqualified from receiving funds appropriated herein:

- (a) Misuse of previous grant-in-aid funds;
- (b) Failure to complete a previous grant-in-aid project due to lack of diligence;
- (c) Diversion of funds or materials from a previous grant-in-aid project to other purpose.

Section 3. Administration. The funds appropriated herein shall be administered in accordance with the provisions of section 101-107 of Title 23 of the Truk District Code (Truk District Law 15-13), and any amendments thereto.

Section 4. Allocation. No municipality shall be permitted to receive grant-in-aid funds from the monies herein appropriated in excess of the amount here listed for that municipality.

Section 5. Application. All applications for the grant-in-aid funds appropriated herein shall be submitted to the Community Development Office no later than March 31, 1973.

Section 6. Reversion. All funds not expended or obligated by the end of Fiscal Year 1973 shall revert to the General Fund of the Truk District Legislature.

Section 7. Effective Date. This Act shall take effect upon the approval of the District Administrator or upon its becoming law without such approval.
