AN ACT

FOR AN ACT APPROPRIATING THE SUM OF FIFTEEN THOUSAND (\$15,000.00) DOLLARS DE SO MUCH THEREOF AS MAY BE NECESSARY, OUT OF THE GENERAL FUND OF THE TRUK DISTRICT LEGISLATURE, NOT OTHERWISE APPROPRIATED FOR FISCAL YEAR 1972, FOR THE PURPOSE OF PROVIDING FUNDS TO COMPENSATE TREE OWNERS WHOSE TREES ARE DESTROYED BY AND DURING THE CONSTRUCTION OF PUBLIC ELEMENTARY SCHOOLS, DISPENSARIES, PUBLIC ROADS, AND OTHER PUBLIC FACILITIES; AND FOR OTHER FURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. <u>Appropriation</u>. There is hereby appropriated the sum of fifteen thousand (\$15,000.00) do Cors or so much thereof as may be necessary out of the General Fund of the Truk District Legislature, not othewise appropriated, for the purpose of probiding funds to compensate tree woners whose trees are destroyed by and during the construction of public elementary schools, dispensaries, public roads, and other public facilities, and for other purposes.

Section 2. <u>Administration</u>. The District Treasurer or his resignated representative, is charged with the responsibility to administer the funds herein appropriated. He shall distribute the funds upon being presented a written request by the municipal council of the municipality concerned, which request shall have been first signed by the magistrate of that municipality and approved by the District Administrator. Section 3. Limitation. Only tree owners whose trees are destroyed by the Trust Territory Government or by a municipal governemnt project shall be eligible for compensation from the funds appropriated herein, and no monies herein appropriated shall be sued to provide compensation for trees destroyed prior to July 1, 1972.

Section 4. <u>Reversion of Funds</u>. All funds not expended or obligated at the end of Fiscal Year 1973 shall revert to the General Fund of the Truk District Legislature.

Section 5. Effective Date. This Act shall take effect upon its approval by the District Administrator or upon its becoming law without such approval.
