TRUK DISTRICT LAW NO. 22-3

AN ACT

APPROPRIATING TEN THOUSAND DOLLARS (\$10,000.00) OUT OF THE GENERAL FUND OF THE TRUK DISTRICT LEGISLATURE FOR THE TRUK DISTRICT RECREATION FUND; AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Amendment. Subsection (1) of section 7 of Title 25 of the Truk District Code is hereby amended to read as follows:

"(1) There is hereby established the Truk District Recreation Fund. The Truk District Legislature is hereby authorizes to appropriate out of the General Fund of the Truk District Legislature, not otherwise appropriated, such sums as it deems desireable, for the purpose of funding the Truk District Recreation Fund."

Section 2. Amendment. Subsection (2) of section 7 of Title 25 of the Truk District Code is hereby amended to read as follows:

"(2) The management and administration of the Fund shall be responsibility of the Recreation Board. The Fund shall be used to fulfill the following purposes:

- (a) compensation of the Director of Recreation;
- (b) payment of five dollars each per day for those members who work on Charter Day, Congress of Micronesia Day and United Nations Day;
- (c) prizes for all games and sporting events;

(d) interisland traveling expenses of the Recreational Director and miscellaneous expenses in development of other recreational activities; PROVIDED, that:

(i) no more than five hundred dollars may be used for these purposes; and

(ii) under no circumstances will any of the funds appropriated pursuant to this Chapter be used for the purchase or rental of a motor vehicle; and

(e) interisland transportation for athletes participating in organized Recreation Board activities.

Section 3. Appropriation. There is hereby appropriated out of the General Fund of the Truk District Legislature, not otherwise appropriated, the sum of ten thousand dollars (\$10,000.00) for the Truk District Recreation Fund, pursuant to Chapter 1 of Title 25 of the Truk District Code, as amended.

Section 4. Reversion. Any funds herein appropriated not expended or obligated at the end of Fiscal Year 1973 shall revert to the General Fund of the Truk District Legislature.

Section 5. Effective Date. This Act shall become effective upon its approval by the District Administrator, or upon its becoming a law without such approval.
