AN ACT

ESTABLISHING THE TUBERCULOSIS PATIENTS' TRANSPORTATION FUND, APPROPRIATING ONE THOUSAND (\$1,000.00) DOLLARS THEREFOR; AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE:

Section 1. <u>Amendment</u>. Title 17 of the Truk District Code is hereby amended by adding Chapter 9 thereto, to read as follows:

Chapter 9

Tuberculosis Patients' Transportation Fund

Section

201. Establishment.

202. Purpose.

203. Administration.

204. Authorization of Appropriation.

Section 201. Establishment. There is hereby established the Tuberculosis Patients' Transportation Fund.

Section 202. <u>Purpose</u>. The purpose of the Tuberculosis Patients' Transportation Fund is to provide transportation for tuberculosis patients of Truk District to the Truk District Hospital, to provide return transportation to their homes after treatment at the Truk District Hospital, and to provide for each of these patients a one dollar and fifty cents (\$1.50) noon meal during such travel and check-up.

- Section 203. <u>Administration</u>. The Tuberculosis Patients' Fund shall be administered by the District Director of Health Services, Truk.
- Section 204. <u>Authorization of Appropriations</u>. There is hereby authorized an annual appropriation out of the General Fund of the Truk District Legislature, of such sum as the Legislature deems necessary to carry out the provisionss of this Chapter.

Section 2. <u>Appropriation</u>. There is hereby appropriated out of the General Fund of the Truk District Legislature, not otherwise appropriated, the sum of one thousand dollars (\$1,000.00) for the purpose of carrying out the provisions of this Act.

Section 3. <u>Reversion</u>. Any monies herein appropriated not expended or obligated at the end of Fiscal Year 1973 shall revert to the General Fund of the Truk District Legislature. Section 4. <u>Effective Date</u>. This Act shall take effect upon its approval by the District Administrator, or upon its becoming law ithout such approval.
