AN ACT

TO AMEND TRUK DISTRICT LAW 21-14, AS THAT LAW MAY BE CODIFIED, TO PROVIDE FOR ADDITIONAL DISTRICT POLICE OFFICERS, TO APPROPRIATE MONEY THEREFORE, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. <u>Amendment</u>: Section 1 of Truk District Law 21-14 is hereby amended to read as follows:

> "Section 1. <u>Greation</u>: There is hereby created the position of District Police Officer within the Truk District Department of Public Safety. There shall be nine (9) such police officers, all of whom shall be under the supervision of the Chief of Police, Truk District. Six (6) of the forementioned police officers shall be assigned to the outer islands of the Truk District."

Section 2. <u>Amendment:</u> Section 4 of Truk District Law 21-14 is hereby amended to read as follows:

> "Section 4. <u>Authorization of Annual Appropriation</u>: There is hereby authorized an annual appropriation

out of the General Fund of the Truk District Legislature, not otherwise appropriated, of such sum as the Legislature deems necessary to carry out the purposes of this Act.

Section 3. <u>Codification</u>: The Legislature Counsel, or such other person as the Speaker of the Truk District Legislature may designate, is mereby authorized to designate the proper position of the foregoing amendments in the Truk District Code.

Section 4. <u>Appropriation</u>: There is hereby appropriated out of the General Fund of the Truk District Legislature, not otherwise appropriated, the sum of nine thousand four hundred dollars (\$9,400.00) for the mapping out the provisions of Truk District Law 21-14, as amended by this Act.

Section 5. <u>Reversion</u>: Any monies herein appropriated not excended or obligated at the **end of** Fiscal Year 1973 shall revert to the General Fund of the Truk District Legislature. Section 6. <u>Effective Date</u>: This Act shall become effective upon its approval by the District Administrator, or upon its otherwise becoming law without such approval.
