ACT NO. 23-1-2

AN ACT

TO AMEND SECTION 1 OF TRUK DISTRICT LAW NO. 23-10 WHICH ESTABLISHED THE LEGISLATURE BUDGET FOR FISCAL YEAR 1974 AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Purpose. The purpose of this act is to establish a new budget for the funds expected to be available in Fiscal Year 1974 in order to prevent deficit spending.

Section 2. Amendment. Section 1 of Truk District Law No. 23-10 is hereby amended to read as follows:

Section 1. Budget. There is hereby budgeted out of the General Fund of the Truk District Legislature the sum of four hundred thirty thousand four hundred thirty three dollars(\$430,433.00) for the purposes described below:
