

AN ACT

TO APPROPRIATE EIGHT-THREE THOUSAND FORTY DOLLARS (\$83,040.00) TO PAY THE STAFF SALARY EXPENSES OF THE TRUK DISTRICT LEGISLATURE FOR FISCAL YEAR 1974, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Appropriation. There is hereby appropriated out of the General Fund of the Truk District Legislature the sum of eighty-three thousand forty dollars (\$83,040.00) for the purpose of paying the staff salary expenses of the Truk District Legislature for Fiscal Year 1974, to be allocated as follows:

Section 2. Administration of Temporary Employees' Compensation.

The Administrative Officer of the Truk District Legislature shall hire such temporary employees as are necessary for the functioning of the Legislature from time to time, He shall determine the compensation of such temporary employees by either an hourly or a pay period rate.

Section 3. Reversion. Any funds appropriated by this act remaining unexpended and unobligated on June 30, 1974 shall revert to the General Fund of the Truk District Legislature.

Section 4. Effective Date. This act shall take effect upon
approval by the District Administrator, or upon its becoming law
without such approval.
