AN ACT

TO BUDGET THE SUM OF FIVE HUNDRED THOUSAND SEVEN HUNDRED TWENTY-THREE DOLLARS (\$500,723.00) FOR FISCAL YEAR 1974, TO ESTABLISH PRIORITIES; AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. <u>Budget</u>. There is hereby budgeted out of the General Fund of the Truk District Legislature the sum of five hundred thousand seven hundred twenty-three dollars (\$500,723.00) for the purposes described below:
