
 AN ACT

TO APPROPRIATE THE SUM OF TWO HUNDRED FORTY-NINE THOUSAND SEVEN HUNDRED THIRTY-EIGHT DOLLARS (\$249,738.00) FOR THE OPERATION OF THE TRUK DISTRICT LEGISLATURE, INCLUDING CERTAIN LEGISLATURE CREATED PROGRAMS, FOR FISCAL YEAR 1974, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Appropriation. There is hereby appropriated out of the General Fund of the Truk District Legislature the sum of two hundred forty-nine thousand seven hundred thirty-eight dollars (\$249,738.00) for the purposes described below:
