Legislature for two year terms, one of his appointees shall be a member of the Truk District Legislature; two shall be appointed by the District Administrator for two year terms; and the Truk District Peace Corps Director shall be an ex officio member of the Board. The first meeting of the Peace Corps Review Board shall be called by the Speaker, the District Administrator, or the Peace Corps Director. The Legislator shall serve as temporary Chairman until the Board elects a permanent Chairman. The members of the Peace Corps Review Board, except the Peace Corps Director, shall receive compensation for one meal per meeting and shall in addition receive five dollars (\$5.00) per meeting from the funds appropriated pursuant to this chapter, but shall receive no other compensation from funds appropriated by the Truk District Legislature.

Meetings. The Peace Corps Review Board shall meet at least once each quarter in a room designated for its use in the Truk District Peace Corps Building. Additional meetings may be called by the Chairman or by the

Section.

Duties and Powers. The Peace Corps Review
Board shall oversee and review all Peace
Coprs activities in Truk District. It
shall review the program and the policies
of the Peace Corps in Truk. It shall
designate how the funds appropriated
pursuant to this chapter shall be expended.
It shall review the appearance, behavior,
problems, and work of all Peac Corps Volunteers
in Truk District. The Peace Corps Review
Board may recommend the termination and
reassignment of Peace Corps Volunteers
within Truk District. It shall evaluate and
arbitrate disputes arising between Peace
Corp Volunteers and Trukese people.

Section.

Appropriation Authorization. There is hereby authorized an annual appropriation out of the General Fund of the Legislature of such sum as the Legislature deems necessary to support the Peace Corps program in Truk District. Such funds as are appropriated shall be administered by the

Truk District Peace Corps Director
subject to the approval and the priorities
established by the Peace Corps Review Board.

Section 3. Appropriation. There is hereby appropriated out of the General Fund of the Truk District Legislature the sum of ten thousand dollars (\$10,000.00) for the purpose of supporting the Peace Corps program in Truk District.

Section 4. Reversion. Any funds appropriated by this act remaining unexpended and unobligated on June 30, 1974, shall revert to the General Fund of the Truk District Legislature.

Section 5. Effective Date: This act shall take effect upon its approval by the District Administrator, or upon its becoming law without such approval.
