AN ACT

AMEND TITLE 31 OF THE TRUK DISTRICT CODE BY ADDING CHAPTER 2 ENTITLED, COULDMENT OF VEHICLES," AND SECTIONS 100, 101, 102, 103, AND 104 OF LANGE 2 REQUIRING ALL MOTOR VEHICLES TO BE EQUIPPED WITH A PROPERLY COUNTY OF THE PROPERTY OF THE P

IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Amendment. Title 31 of the Truk District Code is bereby amended by adding thereto Chapter 2 to read as follows:

Chapter 2

Equipment of Vehicles

Section 100. Exhaust System Required

Section 101. Permit to Operate

Section 102. Issuance of Permit

Section 103. Display of Permit

Section 104. Penalty

Section 100. Exhaust System Required. Every motor vehicle when operated on the public roads of Truk District shall be equipped with a properly functioning and complete exhaust system consisting of an exhaust pipe, muffier, and tail pipe.

Section 101. Interim Permit to Operate. The owner of any motor vehicle that is not equipped with or that loses the effectiveness of any portion of this system shall immediately report the condition to the District Police Department and receive an Interim Permit to operate.

Interim Permits to operate shall be issued for a

two-wiid period upon proof that the vehicle owner
has ordered the necessary replacement parts from
a local dealer or air mail from a reliable source.

Section 103. Display of Interim Permit.

The Interim Permit to operate shall be displayed in a clearly visible manner on the offending vehicle.

Section 104. Penalty. A person convicted of violating any section of this Chapter shall be guilty of a misdemeanor and shall be liable for a fine of not more than one hundred (\$100.00) dollars or imprisonment for not more than six (6) months, or both such fine and imprisonment.

Section 2. Effective Date. This act shall take effect upon its approval by the District Administrator, or upon its otherwise becoming law without such approval.
