Contract I

AN ACT

TO APPROPRIATE TEN THOUSAND (\$10,000.00) DOLLARS FOR THE PURPOSE OF PROVIDING MATCHING FUNDS TO THE TRUK AGING PROGRAM FOR GRANTS RECEIVED FROM THE TRUST TERRITORY OFFICE ON AGING TO ESTABLISH A DISTRICT PROGRAM FOR THE AGED, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. <u>Appropriation</u>. There is hereby appropriated out of the General Fund of the Truk District Legislature the sum of ten thousand (\$10,000.00) dollars for the purpose of providing matching funds for the Truk Aging Program for grants received from the Trust Territory Office on Aging to establish a district program for the aged.

Section 2. <u>Administration</u>. The sum herein appropriated shall be expended for the purpose herein specified by the Truk Aging Project Coordinator under the supervision of the District Administrator or his officially designated representative, and in accordance with detailed written plans and an estimated budget of expenditures to be approved by the District Administrator or his officially designated representative. All purchase orders, requisitions, invoices, time sheets, and other necessary documents shall be certified as correct by the Community Development Officer and submitted to the District Administrator or his officially designated representative for approval. Upon such approval the District Treasurer shall make certification as to the availability of funds, after which the District Administrator or his officially designated Expresentative shall authorize payment to be made by the District Expressurer. The Truk Aging Project Coordinator shall then commence action = cbligate and expended the funds.

Section 3. Execution Power. The District Administrator is mereby authorized to act as contracting officer in executing all contracts mother agreements which are necessary to carry out the purpose for which this appropriation is made.

Section 4. <u>Reversion of Funds.</u> Any funds appropriated by this remaining unexpended and unobligated on June 30, 1974, shall revert to Seneral Fund of the Truk District Legislature.

Section 5. Effective Date. This act shall take effect upon an approval by the District Administrator, or upon its becoming law action such approval.
