AN ACT

TO ESTABLISH A TRUK FARMERS' AND FISHERMEN'S FAIR FUND, TO APPROPRIATE TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) THEREFORE, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Amendment. Title 13 of the Truk District Code is hereby amended by adding a new chapter to read as follows:

§ \_\_\_\_\_. Established. There is hereby established a Truk Farmers' and Fishermen's Fair Fund.

§ \_\_\_\_\_. Purpose. The purpose of the Truk Farmers' and Fishermen's Fair Fund is to pay for supplies, materials, prizes, and other expenses incurred in the preparation for and holding of the Truk Farmers's and Fishermen's Fair.

§ \_\_\_\_\_. Administration. The Truk District Agriculturist and the Truk District Fisheries Specialist shall administer

the Truk Farmers' and Fishermen's Fair Fund.

§         . Annual Report. The Truk District Agriculturist and the Truk District Fisheries Specialist shall submit an annual report on and accounting for the funds appropriated pursuant to this chapter to the Truk District Legislature by May 10 of each year in both English and Trukese with sufficient copies to provide one for each Legislator.

§         . Appropriation Authorization. There is hereby authorized an annual appropriation out of the General Fund of the Truk District Legislature of such sum as the Legislature deems necessary to carry out the purposes of this chapter.

Section 2. Appropriation. There is hereby appropriated out of the General Fund of the Truk District Legislature the sum of two thousand five hundred dollars (\$2,500.00) for the purpose of funding the Truk Farmers' and Fishermen's Fair Fund.

Section 3. Reversion. Any funds appropriated by this act remaining unexpended and unobligated on June 30, 1974, shall revert to the General Fund of the Truk District Legislature.
