AN ACT

To appropriate the sum of \$356,975 from the General Fund of the Legislature of Truk District for the internal operation of the First Legislature for Fiscal Year 1979, for the remaining three quarters, and for other purposes.

Be it enacted by the Legislature of Truk District that:

Section 1. The sum of \$356,975, or so much thereof as may be necessary is appropriated from the General Fund of the Legislature of the Truk District for the purpose of funding the internal operation of the First Legislature for Fiscal Year 1979 as follows:

1. Staff Salary . . . . .	\$ 75,800
2. Temporary Employees . . . . .	6,000
3. Staff Travel . . . . .	9,000
4. Entertainment Fund . . . . .	4,000
5. Building & Ground Maintenance . . . . .	3,250
6. Vehicle Maintenance . . . . .	1,500
7. Office Supply & Equipment . . . . .	12,250
8. Legislator Allowance . . . . .	31,500
9. Legislator Compensation . . . . .	165,155
10. Budget Review Board . . . . .	1,500
11. Legislature Library . . . . .	4,000
12. Board & Commissions . . . . .	1,500
13. District Travel Fund . . . . .	10,000
14. Miscellaneous Fund . . . . .	500
15. Transportation for outer island legislators to District Center . . . . .	500
16. Life Insurance . . . . .	1,000
17. Standing Committee Fund . . . . .	25,000
18. Social Security Contribution . . . . .	4,520

Section 2. The sum appropriated by Section 1 is allotted to the Speaker who shall be responsible for ensuring that these funds are used only for the purpose(s) specified in Section 1, and that no obligations are incurred in excess of the sum appropriated. Any part of this appro-

...iation not obligated as of September 30, 1979, shall revert to the General Fund of the Legislature of Truk District.

Section 3. The Speaker shall submit a report to the Legislature before May 15, 1979, which shall:

- (1) provide for the full disclosure of the obligations incurred against the sum appropriated by Section 1, and indicate the status of these funds as of April 30, 1979;
- (2) indicate the planned use, during the Final five months of the Fiscal Year, of funds not obligated as of April 30, 1979; and
- (3) present the fiscal support requirement of the internal operation of the Legislature for Fiscal Year 1980.

Section 4. The Speaker is authorized to transfer funds between Subsections (1) to (18), Section 1 of this Act; PROVIDED, however, that the total amount of funds allocated for a Subsection shall not be decreased by more than ten percent.

Section 5. Pursuant to Section 504, Title 21 of the Truk District Code the Staff Salary levels for the remainder of Fiscal Year 1979 shall be increased by 3% over levels of Fiscal Year 1978.

Section 6. This act shall take effect on January 1, 1979 upon approval by the Governor, or upon its becoming law without such approval.
