

AN ACT

APPROPRIATING THE SUM OF ONE HUNDRED FIFTY-TWO THOUSAND ONE HUNDRED THIRTY DOLLARS (\$152,130) FOR OPERATION OF THE TRUK DISTRICT LEGISLATURE FOR FISCAL YEAR 1977.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Appropriation. There is hereby appropriated, out of the General Fund of the Truk District Legislature, the sum of one hundred fifty-two thousand one hundred thirty dollars (\$152,130) for the purposes described below:


Section 2. Transfer of Funds. The Speaker of the Truk District Legislature is authorized to transfer funds from any subsection of Section 1 to any other subsection, provided that the total amount of funds appropriated for a subsection shall not be decreased by more than ten percent.

Section 3. Administration. The Speaker of the Truk District Legislature is authorized to administer the funds appropriated by this Act. The Speaker shall submit a report and accounting on the use of the funds to the Truk District Legislature on or before May 1, 1977.


Section 4. Reversion. Any funds appropriated by this Act remaining unexpended and unobligated on September 30, 1977, shall revert to the General Fund of the Truk District Legislature.

Section 5. Effective Date. This Act shall take effect upon its approval by the District Administrator, Truk, or upon its becoming law without such approval.
