

AN ACT

To amend TDL No. 27-36, the Municipal Operations and Projects Fund, to decrease by twenty-five percent allocations municipal governments, to appropriate \$39,750, therefor, and for other purposes.

BE IT ENACTED BY THE TRUK DISTRICT LEGISLATURE THAT:

Section 1. Amendment. Section 84, Chapter 4, Title 23 of the Truk District Code, as amended by TDL No. 27-36, is hereby amended as follows:

"§ 84. Allocation. The allocation of funds among the municipalities shall be determined by the annual appropriation establishing the amount of funds for each municipality to be based on the following:

<u>Municipal Residents</u>	<u>Amount</u>
1. 100 or less . . . . .	\$1,000
2. 101 to 200 . . . . .	1,500
3. 201 to 300 . . . . .	2,000
4. 301 to 401 . . . . .	2,500
5. 401 to 500 . . . . .	3,000
6. 501 to 600 . . . . .	3,500
7. 601 to 800 . . . . .	4,500
8. 801 to 1,000 . . . . .	5,500
9. 1,001 to 1,500 . . . . .	7,000
10. 1,501 to 2,000 . . . . .	8,000
11. 2,001 to 3,000 . . . . .	9,500
12. 3,001 to 5,000 . . . . .	12,500
13. 5,001 or more . . . . .	15,000


Section 2. Appropriation. The sum of \$39,750, or so much thereof as may be necessary is appropriated from the General Fund of the Truk District Legislature for the purpose of funding the Municipal Operations and Projects Fund for the first quarter of fiscal year 1979, as follows:


Section 3. Reversion. Any part of this appropriation not obligated as of December 31, 1978, shall revert to the General Fund of the Truk District Legislature.
