

AN ACT

Relating to Section 1, Part I, Chapter 5, Title 21 of the Truk State Code, regarding compensation of Senators, appropriating funds therefor, and for other purposes.

Be It Enacted By The Legislature of Truk State.

Section 1. Section 1, Part I, Chapter 5, Title 21 of the Truk State Code is hereby amended follows:

"Section 1. Annual Salary for Senators. The salary of each Senator of the Legislature shall be twelve thousand dollars a year; provided that the Speaker of the Legislature shall receive a salary of fourteen thousand dollars a year."

Section 2. Section 2, Part I, Chapter 5, Title 21 of the Truk State Code is hereby amended, to read as follows:

"Section 2. Senator's Allowances. There is hereby authorized an annual appropriation from the General Fund of the Truk Legislature for an annual office expense allowance of \$5,000 to each Senator of the Legislature."

Section 3. Appropriation.

(a) There is hereby appropriated from the General Fund of the Truk Legislature the sum of \$56,000 to carry out the purpose in Section 2 of this act, and to supplement Act No. 1-43, the Internal Operations Fund.

(b) The sum appropriated by Section 3 is allotted to the Speaker of the Truk Legislature who shall be responsible to the Legislature for ensuring that these funds are used only for the purposes specified in Section 3, and that no obligations are incurred in excess of the sum appropriated. Any part of this appropriation not obligated as of September 30, 1982, shall revert to the General Fund of the Truk Legislature.

(c) The Speaker shall submit a report to the Legislature before April 15, 1982, which shall:

(1) provide for the full disclosure of the obligations incurred against the sum appropriated by Section 1, and indicate the status of these funds as of April 1, 1982;

(2) indicated the planned use during the remainder of the Fiscal Year, of funds not obligated as of April 1, 1982, provided that a supplemental report covering the actual use and obligation of the fund shall be submitted to the Legislature or an appropriate committee thereof within 20 days after the closing of the Fiscal Year; and


(3) present the fiscal support requirements of the Senator's allotment for Fiscal Year 1983.


Section 4. Effective Date.

(a) Section 1 of this act shall take effect upon approval by the Governor, or upon its becoming law without such approval and after the end of the term of the First Legislature, pursuant to the provision of Section 10, Article III of the Charter for the Truk State Government, Public Law No. 7-62, 1977.


(b) Section 2 of this act shall take effect upon approval by the Governor, or upon its becoming law without such approval.

(c) Section 3 of this act shall take effect on October 1, 1981, upon approval by the Governor or upon its becoming law without such approval.
