Tetten 415-1. Itemwochun. Ei Sopun epwe iteni "Annukun Public Projects."

Tetten 415-2. Kuna-an. Ei napanap mei fis non ei fansaun ren tumunun niwinin ira mei tano seni angangen ekkewe public projects a men fakkun awosukosuk pwan minen noamw. Ei napanap mei murino an epwe ekkesiwin ren an epwe apachanong ekkewe choon angangen ei muu

non mwokutukutun me foffoun ei angang. Napanapen amwokutun ei angang iei a affatetiw non ei Annuk, chinoon chok ika e pusin affatetiw me ren ei Annuk, epwene ataeno meinisin Annukun ei sakkun mei fis me mwan, rules me regulations mei for me kawor fan itan ei angangen kamoon niwinin ira.

Tetten 415-3. Awewen Foos.

(a) "Choon Claim", a wewe ngeni ioon aramas mei entaiten ngeni niwinin met an ira mei tano;

(b) "Tano", a wewe ngeni ira mei tano non och ika unusan meinisin usun an affatetiw me non ei Sopun;

(c) "Division", a wewe ngeni ewe Division of Land Management mei namw non ewe Putaen Resources and Development;

(d) "Public Project", a wewe ngeni ekkewe project an Muun Trust Territory, Muun Merika, Muunapen Federated States of Micronesia, Muun Chuuk, ika Muun Fonu mei auchea an epwe katano fetaan aramas ira ren forutaar, mei pwan pachenong ekkewe project mei kawor seni ekkewe muu mei affat asan nge mei contract ngeni private business; me

(e) "Ira", a wewe ngeni ira mei uwa ika pwan metekewe sakkun ira mei kamoo fan pungun ei Sopun.

Tetten 415-4. Niwinin. Ion aramas minneka an ewe ira mei tano ren angangen ewe public project epwe entaiten ngeni niwinin ira mei tano fan pungun ei napanapen me aukukun niwin non ei Sopun.

Tetten 415-5. Annenetetaan. Esap wor och claim ren kamoon ira mei tano epwe kamau chinon chok ika ewe ira mei tano a annenetata non ei napanap mei affatetiw faan:

(a) atootun me planin ewe project epwe for epwe kawor ngeni ewe Division nefinen 30 ran me mwen poputaan ewe project, epwe affatatiw:

(i) napanapen ewe project, pwan pachenong planin me popun;

(ii) iteiten ira epwe katano, iten ira, minneka an ewe ira epwe ta, ukukun ierin ewe ira, me nenien ewe ira.

(b) murin an ewe Division a angei ewe plan, iwe emon chon chek seni ewe Division epwe asine ngeni ewe samon non ewe municipality e namw ie ewe project ren an epwe fiti ne nengeni ewe neni epwe for ie ewe project;

(c) ewe chan chek me ewe samon repwe wisen nengeni ewe neni epwe for ie ewe project ren an epwe fateno metewe mei nam non ewe Plan mei tori ewe Division ren ewe Project. Kapin ei taropwe epwe titino ngeni ewe samon, ekkewe aramas ar ira mei tano, ewe project director me ewe State Treasurer;

(d) fansoun an ewe project director a wes an angang ren ekkewe ira epwe katano, iwe epwe awora kapin ncun repotun an angang ngeni ewe Division me ekkewe aramas ar kewe ira;

(e) ika pwe ewe project director ese esinei-ngenii ekkewe Division ika ewe saufonu usun an we angang ewe a fen wes, iwe ewe saufonu epwe esinei-ngenii ewe Division iwe ewe Division epwe chosani ewe claim nge ika a pwa pwe mei pung iwe ewe Division epwe awora repotun metekewe mei pung ngeni ewe Kepina;

Tetten 415-7. Annukun Pochokunan. Esap wor claim ren niwinin ira mei tanc epwe katonong murin ruu ier seni ewe fansoun ekkewe ira ra katano. Tetten 415-9. Monien Public Project. Iteiten met public projects epwe esenipato taanoon fetaan aramas irapwan kuu ei niwinin ira mei affat non ewe Sopun mei kawor monian me ren Legislature epwe eimu-weno ukukun unungat persent (3%) me non unuse monian-we ren an epwe kamo ngeni met ira mei tano ren ewe angang. Met nussun ewe moni mei kaimuno ren niwinin ira mei ta me non ewemonien public project epwe pwan nounou ngeni ewe project. Met esemwo wes kamoon me ren ewe moni mei kaimuno ren niwinin ira me non ewe monien project epwe pwan soposop ika ammasou sefan me ren ewe State.

Tetten 415-10. Tipisin. Ika emon aramas a tipis ren an atai ew Tetten me non ei Annuk, ika fori och poraus mei mwaken ren taropwen claim ren ira mei tano, epwe paking won ukukun esap nap-seni \$1,000, ika kanupus non ukukun esap nangatam seni wonu(6) maram, ika ir me ruwoch.

Tetten 415-11. Mumutaan Kaworen Monien Ier. Iei a mumuta an epwe kawor monien iteiten ier seni ewe Monienapen Legislature ren fan asengesin ei Sopun".

Tetten 2. Kaworen Moni. Ukukun 50,000 iei a kawor seni ewe Monienapen ewe Legislature-un Chuuk ren fan asengesin ei Annuk.

Tetten 3. Ei moni mei kawor me ren Tetten 2, epwe no-ngen ika einet ngeni ewe State Treasurer, ewe epwe wisen tumunu nounoun me mwokutukutun fan itan ewe Legislature ren an epwe fiti chok metawe mei affat me non Tetten 2 ren nounoun ewe moni.

Tetten 4. Ewe Treasurer epwe awora an repot 20 ran me murin sponon ewe fiscal year, epwe affatatiw nounoun ewe moni, pwan awora met anapanapen ukukun moni epwe kawor fan iten ewe program non ewe Fiscal Year epwe tapweto.
