AN ACT

To amend the Executive Organization Act, Truk State Law No.3-25, and for other purposes.

Be it enacted by the Legislature of Truk State.

Section 1. Section 2 of Truk State Law No.3-25, is hereby amended as follows:

"Section 2. Executive Organization. In addition to the Office of Governor and Office of Lieutenant Governor, the Executive Branch of the government of the State of Truk shall consist of the following Departments and Offices:

- 1) Department of Education;
- 2) Department of Health Services;
- Department of Public Works;
- 4) Department of Resources and Development;
- 5) Department of Public Affairs;
- 6) Deaprtment of Finance;
- 7) Department of Public Safety;
- 8) Office of Transportation;
- 9) Office of Planning;
- 10) Office of Personnel;
- 11) Office of Property and Supply; and
- 12) Office of Attorney General."

Section 2. Section 3 of Truk State Law No.3-25, is hereby amended as follows:

"Section 3. <u>Heads of Departments and Offices</u>. The titles of the Heads of Departments and Offices established by Section 2 of this Act shall be as follows:

- 1) Director of Education;
- 2) Director of Health Services;
- 3) Director of Public Works;
- 4) Director of Resources and Development;
- 5) Director of Public Affairs;
- 6) Director of Finance;

- 7) Director of Public Safety;
- 8) Transportation Officer;
- 9) Planner;
- 10) Personnel Officer;
- 11) Property and Supply Officer; and
- 12) Attorney General."

Section 3. Section 9 of Truk State Law No.3-25, is hereby amended as follows:

"Section 9. <u>Department of Finance</u>. The Department of Finance shall be composed of the Divisions of Budget, Revenue, and Treasury, and shall provide for the administration and management of government finance, revenue, budget shall coordinate all financial grants and assistance to the State Government, and shall coordinate and prepare annual and long term budgets."

Section 4. Section 11 of Truk State Law No.3-25, is hereby amended as follows:

"Section 11. Office of Transportation. The Office of Transportation shall develop, operate, administer, maintain and support transportation facilities and systems."

Section 5. Section 22 of Truk State Law No.3-25, is hereby amended as follows:

"Section 22. Absence or Disability of Governor and Lieutenant Governor. In the event of the absence of the Governor and Lieutenant Governor from the State of Truk, or the inability of both, to exercise and discharge the powers and duties of their offices, such duties shall devolve upon the following officers during such absence or disability in the following order of succession:

- 1) Director of Public Affairs;
- Director of Resources and Development;
- Director of Finance;
- 4) Director of Education;
- 5) Director of Public Works;

- Director of Health Services;
- Director of Public Safety; and
- Attorney General."

Section 6. This Act shall take effect upon approval by the Governor, or upon its becoming law without such approval.
