## AN ACT

To amend the Municipal Operations and Projects Fund, to appropriate the sum of \$159,000 from the General Fund of the Truk Legislature for the purpose of funding the Municipal Operations and Projects Fund, and for other purposes.

Be it enacted by the Legislature of Truk District:

Section 1. Amendment. Section 83, Chapter 4, Title 23 of the Truk District Code, as amended, is hereby further amended to read as follows:

"Section 83. Report. The Magistrate of each Municipality shall submit a report and accounting on the use of the funds, with copies of the ordinances authorizing and directing expenditures of funds, to the Legislature on or before May 1 of the Fiscal Year of the appropriation. A municipality shall use the fund obtained under this Chapter only for the purposes stated in Section 81 and as directed in its municipal ordinance. If the fund is expended or used for any other purposes or in any way misappropriated, the person who is found to have misappropriated or misused the fund shall personally repay to the General Fund of the Truk Legislature the total amount misappropriated or misused. A municipality is eligible to receive fund from the General Fund of the Legislature under this Chapter when a report and accounting is submitted and accepted by the Legislature or a committee thereof."

Section 2. Appropriation. The sum of \$159,000, or so much thereof as may be necessary is appropriated from the General Fund of the Truk Legislature for the purpose of funding the Municipal Operations and Projects Fund for Fiscal Year 1980, as follows:
