AN ACT

To appropriate the sum of \$250,000 from the General Fund of the State for the purpose of funding certain Capital Improvement Projects of the Department of Resources and Development for Fiscal Year 1987, to designate the same as State Matching Fund for the funds provided by the FSM Congress for Truk State, and for other purposes.

Be it	enacted by the Legislature of Truk State:
1	Section 1. The sum of \$250,000, or so much thereof as may be
2	necessary, is appropriated from the General Fund of the State for the
3	fiscal year ending September 30, 1987, for the purpose of funding
4	Capital Improvement Projects of the State Department of Resources and
5	Development, to be allocated as follows:
6	1) Coconut Rehabilitation Program \$50,000;
7	2) Broiler Project/Hatchery 70,000;
8	3) Feed Mill Project 80,000; and
9	4) Marine Service Center 50,000.
10	Section 2. The sum appropriated by Section 1, is hereby desig-
11	nated and shall be used as matching funds for the funds appropriated by
12	the FSM Congress for Truk State for FY'87, and these funds shall be
13	administered by and are allotted to the Governor, who shall be respon-
14	sible for ensuring that they are used only for the purpose specified in
15	Section 1, and in accordance with the State Financial Management Act,
16	and that no obligations are incurred in excess of the sum appropriated.
17	Any part of this appropriation not obligated as of September 30, 1987,
18	shall revert to the General Fund of the State.
19	Section 3. The Governor shall submit a report to the Legislature
20	before April 15, 1987, which shall:
21	 Provide for the full disclosure of the obligations
22	incurred against the sum appropriated by Section 1, and
23	indicate the status of the funds as of April 1, 1987; and
24 .	indicate the planned use, during the remainder of
25	the fiscal year, of funds not obligated as of April 1, 1987,
26	provided that a supplemental report covering the actual use
27	and obligations of the funds shall be submitted to the
28	Legislature or an appropriate committee thereof within 20 days

after the closing of the fiscal year.

1	Section 4. This Act shall take effect upon approval by the
2	Governor, or upon its becoming law without such approval.
