EW NOPUNG

A ekkesiwini Annukun Chuuk No. 4-82, ewe Mortlocks Development Authority, ren an epwe akukunano kinikinin me aukukun ewe Authority pwan fori ekkoch ekkesiwin ngeni masowan ewe Authority, me pwan ren ekkoch popun.

Epwe pung me ren ewe Legislature-un ewe Muun Chuuk.

Tetten 1. Ekkesiwin. Tetten 1, 2, me 4(1), 4(2), 4(4) me non Annukun Chuuk No. 4-82, iei ra ekkesiwin ngeni ekkei ititin:

"Tetten 1. Forutan ewe Authority. Ewe Mid-Mortlocks Development Authority (MMDA) iei a foruta fan pochokunan annukun Truk State me Federated States of Micronesia. Ewe Board non ewe Authority epwe wisen finata nenien ewe ofesin ewe Authority."

"Tetten 2. Neni Epwe Ku Ei Angang. Ewe Authority epwe atufichi ekkei municipalities a mak fan non State of Truk:

- (1) Namoluk;
- (2) Ettal;
- (3) Moch; me
- (4) Kuttu."

"Tetten 4. Board of Directors.

(1) Forutan. Epwe wor ew Board of Directors non ewe Mid-Mortlocks Development Authority, an epwe wisen tumunu pwan nemeni ewe Authority.

(2) Choon. Epwe ukukun 12 choon ewe Board. Ruomon seni ew me ew ekkewe municipalities mei affata non Tetten 2, repwe kefinita seni ar kewe municipal councils, ekkewe State Senator me ewe National Senator seni ewe kinikin, iwe pwan tupun Governor-we ika pwe mei wor, i epwe chok choon, nge esap pwan tongeni vote. Ekkewe choon ewe Mortlock Development Authority iei ir seni ewe kinikinin Mid-Mortlock repwe choni ei Mid-Mortlock Development

Authority ren ar repwe wiis tori muchunoon ar kewe terms me won ewe Mortlocks Development Authority. Ika pwe ese wor tupun Governor-we non ewe neeni, iwe chon ewe Board epwe chok ukukun 11. Ekkewe State me National Senators repwe wiis won ewe Authority non chok fansoun ar Senator.

(3) Nangataman Fansoun Wiis. Nangataman fansoun wiisen ekkewe ra tupuni ekkewe municipalities epwe ukukun unungat ier, chinoon chok ika epwene poputa fansoun ar wiis, me amasowa wiis mei poon, epwe pwan chok usun met a affat non ei annuk. Fansoun poputan wiser kewe epwe poputa non ewe ran ra efisi ar aewin mwiich non.

(4) Aewin Mwiich. Esap mang seni one (60) ran me murin poputan pochokunen ei annuk, ewe Board epwe efisi an mwiich ren an epwe finata noun nouwiis, pwan fori ekkoch an angang. Non an aewin mwiich, chon ewe mwiich re wisen tupuni ekkewe municipalities repwe uttut (by lot) ren nangatamen ar repwe chooni ewe Board, epwe iei usun napanapan:

- (a) ruomon repwe wiis non ew ier;
- (b) unumon repwe wiis non unungat ier; pwan
- (c) unumon repwe wiis non unungat ier.

Tupun Governor-we epwe wisen akokoou ewe aewin mwiich, nge ika pwe ese wor tupun Governor non ewe neeni, iwe ewe Chairman-un ewe Mortlocks Advisory Council epwe wisen akokoou, epwe pwan wisen nemeni ewe mwiich tori fansoun ra kefinita ekkewe wesewesen nouwiis, usun a mak non Kinikinin (7) me non ei Tetten.

(5) Neni Ika Wiis mei Ponuno. Ew neni ika wiis mei ponuno me won ewe Board epwe ammasou non napanapen usun chok an finata monun me nepoputan. Nupwen fansoun a wor ew neni mei poon, ewe Chairman, nge ika ese nomw, ewe a wisen nemeni mwiich epwe esine ngeni chon ewe Board usun ewe wiis mei poon, pwan ewe municipal council a wisen finata ewe wiis a ponuno.

(6) Toou.

(a) Choon ewe Board repwe tongeni tou seni wiser won ewe Board nupwen ar absent seni ar mwiich non tetteninoon unungat mwiich, ika seni ar rese tufich non wiser kewe, ika ren ar rese fori angangen wiser kewe, ika ren foffoorungaw non wiis.

(b) Ren an emon chon ewe Board epwe tongeni tou seni wisan, epwe ukukun unungat-ne-ruwanu-wen chon ewe Board repwe tipeew non ar fout. Porausen an emon epwe tou seni wisan, epwe akkomw foor, esap kisi-seni inik raan me mwen ar repwe angang won, napanapan an epwe foor epwe chok fiti met mei affat non ei by-laws an ewe Authority, epwe pwan affata popun me sakkun ewe tipis ewe aramas a fori, ika pwan affata ion chon pwarata me pwan pisekin pwarata epwe kawor ren ewe angangen kapungun katou.

(c) Ewe State Court epwe wisen nomw ren ewe pochokunen aani ewe kapungun katou.

(7) Nouwiis. Ewe Board epwe finata seni chon ewe mwiich emon chairman, vice-chairman, me Secretary/Treasurer. Ewe Chairman epwe wisan nemeni mwiichen ewe Board, nge ika ese nomw, iwe ewe Vice-Chairman. Nge ika ir me ruomon rese nomw, iwe ewe Secretary/Chairman. An ewe Authority by-laws epwe pusin awora me affata ion epwe wisan nemenem nupwen ekkei nouwiis rese nomw meinisin.

(8) Fansoun Mwiichenap. Mwiichenap epwe fis esap kisiseni fan ew non ew kuachen ew ier, nge fansoun me nenien mwiich epwe finien ewe chairman, usun a affat non noun by-laws.

(9) Mwiich Atapwanapwan. Mwiich atapwanapwan mei tongeni fis me ren chok mefien ewe chairman, ika pwan seni chon mwiich, fan tipeewin ew-ne-unungatin chon ewe Board non ar tungor, napanapan akokoon me esinesinen ei sakkun

mwiich epwe affat non by-laws.

(10) Quorum. Epwe wor fumon (7) chon mwiich ir mei nomw iwe a tongeni quorum me fis mwiich ren.

(11) Executive Committee. Ewe Board mei tongeni fan pungun an by-laws, forata ew Executive Committee, fiti ukukun chon me wiser ika ar angang.

(12) Rekotun Mwiich. Mwiich meininis an ewe Board me ewe Executive Committee epwe suuk ngeni ese nifinifin aramas ika public, nukun chok ika pwe mei wor mettoch mei mwonomwon ren porausen emon chon angang epwe wor poraus won. Ewe Seketery/Treasurer, nge ika ese nomw, iwe emon chon Board epwe finita fan pungun by-laws, epwe wisen tumunu unusen porausen me rekotun mwiich fansoun meininis, iwe epwe pwan mumuta ngeni aramas ar repwe katon non ese nifinifin fansoun me neeni, usun met by-laws a affata, chinon chok mettoch mei mwonomwon usun porausen emon chon angang ika chon mwiich."

Tetten 3. Kaworen Moni.

(1) Iei a kawor ukukun \$25,000, ika fite ukukun epwe tongeni naaf, seni ewe Monienapen ewe Muun Chuuk ren fan asengesin monien ewe Mid-Mortlock Development Authority, non Fiscal Year 1985.

(2) Ei ukukun moni mei kawor non Kinikinin-Tetten (1) me non ei Tetten, epwe nomw fan tumunuwen me no-ngeni ewe Board of Directors non ewe Authority, ewe epwe wisen tumunu ewe moni fan iten ewe Kepina non Chuuk, ren an ewe moni epwe chok nounou ngeni met ewe popun mei affat non Kinikinin-Tetten (1), epwe pwan fiti pungun ewe State Finance Management Act, iwe esap pwan wor nounoun ei moni epwe nap seni ei ukukun mei kawor. Nussun moni esemwo it ne nounou me non ei moni non September 30, 1985, epwe niwinsefan ngeni ewe Monienapen Muun Chuuk.

(3) Ewe Board of Directors non ewe Authority epwe wisen awora an repot ngeni ewe Legislature me mwen April 15, 1985, epwe affatatiw:



(b) napanapen an ewe moni esemwo nounow non April 1, 1985, epwe nounou non metewe nussun ewe fiscal year, nge och poposopun report won ewe nussun moni epwe pwan kawor ngeni ewe Legislature ika ew committee mei wenengeni, nefinen 20 ran me murin saponon ewe fiscal year, pwan


(c) ukukun moni epwe pwan kawor ren ewe Authority non Fiscal Year 1986.
