d) aukukun an citizen-in FSM ika Chuuk repwe pach me ar non nemenemen me tumunun ewe sopai, nge ika ewe chon sopai mei charter nukun Chuuk ika FSM, epwe ifa ukukun me nonnoon mumutaan me tipemecheresin, ika mei wor atootun, an ewe sopai epwe forata ew pekin an we angang non Chuuk ika FSM mwach kaan, pwan ika epwe awora me mutata 51 percent-in sea me monien nongonong ngeni aramasen Chuuk ika FSM;

(2) Ei moni mei kawor me ren Tetten 1 epwe no-ngen ika einet ngeni ewe Kepina, ewe epwe wisen tumunu me nemeni ei moni ren an epwe chok fiti met ewe popun mei affat non Tetten 1, epwe pwan fiti kapasen ewe State Financial Management Act, iwe esap pwan wor nounoun me mwokutukutun ei moni epwe nap seni ei ukukun mei kawor. 
(c) awora ukukun monien ewe Board non Fiscal Year 1986.
