## AN ACT

To appropriate the sum of \$25,000, from the General Fund of the Truk State Government for the purpose of funding compensation of the damage of trees and crops during the construction of public projects, and for other purposes.

Be it enacted by the Legislature of Truk State.

Section 1. The sum of \$25,000, or so much thereof as may be necessary, is appropriated from the General Fund of the State for the purpose of funding compensation for the damage of trees and crops during the construction of public projects. This fund shall be allocated to the five congressional election districts in Truk State for the compensation of claims, as follows:

- 1) First Election District ----- \$ 5,000;
- 2) Second Election District ----- 5,000;
- 3) Third Election District ----- 5,000; and
- 4) Fourth Election District ---- 5,000.

The Fifth Election District shall be allocated the amount of its true and provable claim as determined by the allottee through the services of the Division of Land Management of the Department of Resources and Development; but under no circumstances shall such allocation for the Fifth Election District exceed \$5,000. The allottee may allocate any unused balance of the maximum \$5,000 hereby appropriated and allocated to the Fifth Election District, among any of the other Election Districts above named in this Section, for the purposes indicated in this Section, and according to the true and provable claims from such Election Districts, in such specific amounts as the allottee, through the Division of Land Management, may deem equitable and fair.

Section 2. The sum appropriated by Section 1 shall be administered by and is allotted to the Governor, who shall be responsible to the Truk State Legislature for ensuring that these funds are used only for the purposes specified in Section 1, and in accordance with the State Financial Management Act, and that no obligations are incurred in excess of the sum appropriated. Any part of this appropriation not obligated as of September 30, 1985, shall revert to the General Fund of the Truk State Government.

Section 3. The Governor shall submit a report to the Legislature before April 15, 1985; which shall:

- 1) provide for the full disclosure of the obligations incurred against the sum appropriated by Section 1, and indicate the status of the funds as of April 1, 1985; and
- of funds not obligated as of April 1, 1985; provided that a supplemental report covering the actual use and obligations of the fund shall be submitted to the Legislature or an appropriate committee thereof within 20 days after the closing of the fiscal year; and
- :3) present the fiscal support requirements of the trees and crops damage compensation for Fiscal Year 1986.

Section 4. This Act shall take effect upon approval by the Governor, or upon its becoming law without such approval.
