

Tetten 3. Ewe Kepina epwe awora an report ngeni ewe Legislature me mwen April 15, 1985, epwe affatatiw:


- 1) unusep porausen nounoun ewe moni mei kawor me ren Tetten 1, fongon me ukukun nussun mei wor non April 1, 1985;
