

EW NAMOPUNG.

A forata me iooni takises won amomoon ekkewe pisekin amomo, isois sakau, aean rumwen annut, rentin chitosa me boat; a pwan awora tipisin ese monatiw takises, a ataeno Sopun 1, 5, 9(ewe a forata me ren TSL No. 1-1-13) me 13 me non Itenap 29, me non ewe Pukenapen Annukun Chuuk, me TSL No. 5-103 , me pwan ren ekkoch popun.

Epwe pung me ren ewe Legislature-un ewe Muun Chuuk:

Tetten 1. Itenapan. Ei annuk epwe itemi an Chuuk Annukun Takises forun fan 1985.

Tetten 2. Popun. Popun ei annuk ren an epwe forata takises me iooni ren an epwe awora moni tonong ren fan item kaworen met angangan muun mei namot an epwe kawor fan item aramas.

Tetten 3. Awewen Foos. Ren fan item ei annuk:

1) "Unprocessed", a wewe ngeni mettochun amomo mei chok ususun me nomw non pusin napanapan esemwo sakoono ren an wor met-toch mei kapach ngeni ika fen keimu seni an epwe asokono ununun ika napanapan seni napanapan me mwan.

5) "Heavy Equipment", a wewe ngeni ekkewe sein neman mei watte pwan chou mei pachenong, nge ese chok pwan aukuuk ngeni purutosa, winis ika kureng, sein asosona won aan itan road grader, rora, sein tukotuk itan backhoe, pwan sein tukotuk itan playloader me pwan met sakkun ra nomw non ei tettenin heavy equipment.

6) "Imported", a wewe ngeni angangan atouranong ika chumongunong non Chuuk seni nukun ese pwan nifinifin sakkun anen atononga pisekin amomo.

7) "First Sale", a wewe ngeni akkaewin amomoon pisek
mei fis me murin ewe atun a tonong me wareiti Chuuk ekkewe.

epwe tapweto murin ewe maramen amomo; Nge, ewe Director-un Finance non Chuuk
mei pwan tongeni fori me awora fansoun me atun kamotiwen ei takises seni
fonuwen nukun ei Truk Lagoon. Takises ese kamotiw non ei fansoun a affatetiw

(delinquent).

Tetten 8. Arere Ren Moñññ Pisek Mei Takises. Epwe wor arere pwe:

- 1) Meinisin pisekin amomo ren ekkewe mei affat non Tetten 4 me non ei Sopun mei katonong non Chuuk ren fan iten amomo me ren io-we chon chumong mei wor noun naisenin chumong, ra fen moono ruwanu maram ar tonong non Chuuk, tiwenoon chok ika ewe chon chumong epwe tongeni prufesi pwe resemwo moono iwe ewe Director-in Finance a wesetaan nukunuk pwe esemwo moono; pwan

 - b) non rume ika tiin ika nenien pio ukukun masowan mei nap seni ruwe fluid ounce epwe senis engon ew kinikinin ruwanu fluid ounce, ika na-fituwene;
- 2) Sakau mei pwich, epwe fisu chana ew gallon;
- 3) Wine, epwe ew chana ew gallon; nge ren isoisen win ren fan iten Namanam epwe kepichino seni ei annukun takises.

Ekkewe sakau mei chok tonong non Chuuk ren an fitato sein uwou pisek nge esap nomw Chuuk pwe aan ewe neni nukun Chuuk esap pwan kuu ei takises. Ewe Director-un Finance epwe fori me awora an procedures ren amwokutun me apochokunen ei pekin.

Tetten 12. Takisesin Rent-in Chitosa ika Sein Neman. Iei a foruta ew takises ren rent chitosa ika sein neman won engon percent-in ewe niwinin rent.

Tetten 13. Takisesin Santa Boat ika Sein Neset. Iei a foruta ew takisesin saata sein neset ika boat won engon percent-in ewe niwinin saata.

Tetten 14. Kapachetaan me Kamotiwen Takisesin Rentin Rumw, Chitosa me Boat. Meinisin ekkewe takises a foruta me ren Tetten 11, 12 me 13 epwe kapacheta non ewe fansoun a rent ew rumwen hotel, motel me apartment, chitosa me boat. Meinisin takises mei kapacheta non ewe maram epwe kamotiw ngeni ewe Putaen Finance non ika mwen ewe engon-me-nimuwen ranin ewe maram epwe tapweta murin ewe maramen kapacheta. Ewe Putaen Finance epwe awora naafen fansoun ngeni kamotiwen takises seni nukun ei Truk Lagoon.

2) Ion chon sopai ika chon amomo ekkewe tettenin pisekin amomo mei affat me ren Tetten 4 me non ei annuk, chon aea sopain hotel, motel, apartment, sopain u-drive, rent chitosa me boat, chon isoiso sakau, ese tumunu me awora record mei wenechar, pung me enlet, ese pwan awora ngeni ewe Putaen Finance ekkewe sakkun records fongon me pwan met sakkun taropwen epwe anisi me pwarata enletin ekkewe records, fan pungun Tetten 15 me non ei annuk, epwe tipi-sini tipisin ew misdemeanor, nge ika a punguno pwe a tipis, epwe paking won esap nap seni \$3,000 ew ekkewe kuochen ier mei fis ewe napanapangaw non.

3) Ewe kompenien siip ika sepenin e atai kapasen Tetten 16 me non ei annuk epwe tur non tipisin ew mesdemeanor, nge ika a punguno pwe a tipis epwe paking won esap nap seni \$3,000.

4) Io aramas a tur non tipisin isoiso sakau takisesin esemwo kamotiw epwe tipis ren kanupus esap nangatam seni ew ier ika paking won esap nap seni \$1,500 ika fen ir me ruu ekkei sakkun tipis.
