Tetten 2. Popun. Popun ei annuk ren an epwe anisi efefeitaan pekin moni me pwan awora nemenemem me tumunun monun neset non ewe kinikinin nemepien ewe Muun Chuuk fan pungun ewe Constitution an Federated States of Micronesia.

Ren kutten aukukun niwinin tipis ren taan masowen ei annuk, ewe kapung epwe pwan nennengeni napanapen ewe foffor, popun ika weweochun an fis ewe foffor, ifa ukukun ewe napanap, met sakkun ewe foffor ren pekin sapongawan me ika ewe chon fori ewe foffor mei

ifa sakkun aramas, pwan uruwoon manawen aramas ren foforungawan me mwan, me pwan met ewe soukapung epwe pwan require-ini.

(2) Ewe State Attorney General mei mumuta an epwe atoura ngeni kapung meinisin case pwan pusin fori angangen mwokutun pekin atoura ngeni kapung me etipisi fofforungawan me taan ei annuk, pwan wisen tinikeni an epwe fis ekkewe pakking me niwinin taan ewe annuk. 


