Be it enacted by the Legislature of Truk State:

	21	coordination and preparation of annual and long term budgets
	22	of the State. This process includes also budget formulation,
	23	review of allotment issuance, forcasting and fiscal control."
	24	Section 5. Amendment. Section 22 of Truk State Law No. 3-25
	25	is hereby amended to read as follows:
	26	"Section 22. Absence or Disability of Governor and

	29	the inability of both, to exercise and discharge the powers
