## AN ACT

To amend Truk State Law No. 6-7, Section 2 as amended by Truk State Law No. 6-9 to repeal the appropriation of \$545,179, as Loan Re-

payment, and for other purposes.				
Be it enacted by the Legislature of Truk State:				
Section 1. Amendment. Section 2 of Truk State Law No.				
2 . 6-7, as amended by Truk State Law No. 6-9, is hereby amended				
by repealing Item (3), the appropriation of \$545,179 for Loan				
4 Repayment, and reflecting the reduction in the total amount				
appropriated for Section 2, to read as follows:				
6 "Section 2. Operating Expenses of Other Programs.				
7 The sum of \$849,480 (\$453,080-Current Account; \$396,400-				
8 Local Revenue), or so much thereof as may be necessary,				
is hereby appropriated from the General Fund of the State				
for the fiscal year ending September 30, 1987, for the				
purpose of funding the operating expenses of the other				
agencies and programs. The Governor shall be the allottee				
of these funds including the Municipal Operation; while				
4 the Legal Services Office shall be the allottee of its				
own funds. The funds shall be apportioned as follows:				
1) Legal Services Subsidy \$20,000;				
17 2) Municipal Operation 400,080;				
18 3) Vocational Rehabilitation				
19 (Matching) 50,000;				
4) Home Economic Program Expanded				
Food & Nutrition Education 15,000;
