AN ACT

To amend Section 3 of Truk State Law No. 5-108, the State Foreign Investment Act; to provide for seating a State Senator as a board member, and for other purposes.

Be it enacted by the Legislature of Truk State:

Ţ	Section 1. Amendment. Section 3 of flux State Law No. 3-100,
2	the State Foreign Investment Act, is amended as follows:
3	"Section 3. State Foreign Investment Board-Membership.

- (a) The Truk State Foreign Investment Board, hereinafter called the "Board", is hereby established. The Board shall be composed of five voting members. The Governor shall appoint two members with the advice and consent of the Truk State Legislature. The Speaker of the Truk State Legislature shall appoint four members, one of whom shall be a member of the Legislature and be an ex-officio, non-voting member. The Director of the State Department of Resources and Development shall also serve as an ex-officio, non-voting member of the Board.
- (b) Members shall serve for a two-year term. A member appointed to fill the vacancy occurring during the term for which his precedessor was appointed shall be appointed for the remainder of that term. Each Board member shall hold office until his successor is appointed and qualified. Board members shall be eligible for reappointment.
- (c) Appointments submitted by the Governor when the Legislature is not in session, shall be consented to by a committee established or designated for that purpose by the Speaker of the Truk State Legislature; provided the Governor's initial appointments of members shall be made no longer than thirty days after the effective date of this act; provided, that should the Governor fail to appoint his

1	members then the Speaker shall appoint five voting
2	members.
3	(d) Voting members of the Board shall all be
4	citizens of the Federated States of Micronesia and
5	residents of the State of Truk at the time of appoint-
6	ment.
7	(e) The Board shall elect from among its members,
8	a Chairperson, a Vice-Chairperson, and a Secretary-
9	Treasurer during its first meeting.
10	(f) Three voting members of the Board must be
11	present to make up a quorum and action can only be taken
12	by a majority vote of the members present.
13	(g) Vacancies in the membership of the Board
14	shall be filled in the same manner as the original
15	appointment with the Speaker filling vacancies should
16	the Governor fail to act. A vacancy exists in the case
17	of death, resignation, or removal of any Board members."
18	Section 2. Effective Date. This act shall take effect upon
19	approval by the Governor, or upon its becoming law without such
20	approval.
