AN ACT

I: further amend Sections 2, 4, and 12 of Truk State Law No. 6-16, as amended by True State Law No. 6-23, and for other purposes.

HE IT ENACTED BY THE LEGISLATURE OF TRUK STATE:

- Section 1. Amendment. Section 2 of Truk State Law No. 6-16 is further mended to read as follows:
 - "Section 2. Members of the Convention. Members shall be known as delegates. The Convention shall consist of 28 delegates, all of whom shall be residents of Truk and citizens of the Federated States of Micronesia. Each of the 13 Election Prencincts, as designated in the State Charter, shall elect at a special or general election on the First Thursday of April, 1988, delegates in the numbers shown in Article IX of the Truk State Charter." Section 2. Amendment. Section 4 of Truk State Law No. 6-96, is further mended to read as follows:
 - "Section 4. Session of the Convention. The Convention shall be convened at 9:30 a.m., on the First Monday in June, 1988, and shall continue to be in session for a period of not more than a total of 60 meetings or working days. The Convention shall meet Monday through Friday except, holidays, PROVIDED, that the Convention sessions may be held on weekend or holidays, or the Convention may recess for a period of not to exceed a " total of 15 days by a majority vote of the Convention delegates." Section 3. Amendment. Section 12 of Truk State Law No. 6-16 is further mended to read as follows:

"Section 12. Referendum."

- 1) The Governor shall, by proclamation, set a date for the referendum on the Constitution no later than 90 days after receipt by the Governor of a copy of the adopted and signed Constitution as transmitted by the Convention.
- 2) Except as otherwise provided in this Section, the provisions of the Truk State Election Act of 1978, as amended apply to the referendum, provided, however, that all candidates who have filed qualifying nomination petitions as of December 1, 1987 shall remain eligible as candidates in the

1	election notwithstanding Section 14(1) of Truk State Law No. 27-1-16.
2	3) The referendum ballot shall appear substantially as follows:
3	"STATE CONSTITUTIONAL REFERENUM:
4	Do you approve of the Truk State Constitution as adopted by the Constitu-
5	tional Convention?
6	Yes / / No / ''
7	4) The results of the referendum shall be certified by the Election
8	Commissioner prose certification shall be the solemn declaration of the
9	approval of the Constitution by the people of the State of Truk. Should
10	there be any question regarding the referendum and the results thereof, th
11	decision of the Truk State Legislature shall be final."
12	Section 4. Effective Date. This Act shall take effect upon approval by
13	the Governor, or upon its becoming law without such approval.
