To appropriate the sum of \$100,000 from the General Fund of the State for the purpose of supplementing the operations of the Executive Branch, the Legislative Branch and the Judicial Branch of the Truk State Government for the fiscal year ending September 30, 1988, and for other purposes.

1	Section 1. The sum of \$100,000, or so much thereof as may be		
2	necessary, is appropriated from the General Fund of the State for the purpose		
3	of supplementing the operations of the Executive Branch, the Legislative		
4	Branch and the Judicial Branch of the Truk State Government for the fiscal year		
5	ending September 30, 1988, to be allocated as follows:		
6	(1) Executive Branch\$ 6,000		
7	(2) Legislative Branch 91,000; and		
8	(3) Judicial Branch 3,000.		
9	Section 2. The sums appropriated by Section 1, shall be administered		
10	by and are allotted to the respective heads of the three branches who shall be		
11	the allottees for the funds appropriated for their respective branches, and		
12	who shall be responsible for ensuring that these funds are used only for the		
13	purposes specified in Section 1, and in accordance with the State Financial		
14	Management Act, and that no obligations are incurred in excess of the sums		
15	appropriated. Any part of this appropriation not obligated as of September		
16	30, 1988, shall revert to the General Fund of the State.		
17	Section 3. The heads of the above branches as allottees for the funds		
18	shall submit reports to the Legislature before April 15, 1988, which shall:		
19	(1) provide for the full disclosures of the obligations		
20	incurred against their respective funds appropriated by Section 1,		
21	and indicate the status of the funds as of April 1, 1988; and		
22	(2) indicate the planned use during the remainder of the		
23	fiscal year of funds not obligated as of April 1, 1988, as to their		
24	respective funds; PROVIDED, that a supplemental report covering		
25	the actual use and obligation of the funds of each branch shall		
26	be submitted by each head to the Legislature or an appropriate		
27	committee thereof within 20 days after the closing of the fiscal		
28	year.		

1	Section 4. This act shall t	cake effect upon approval by the Governor,
2	or upon its becoming law without suc	ch approval.
