

AN ACT

To appropriate the sum of \$30,000 from the General Fund of the State for the purpose of funding participation of the Legislature of Truk State at the conference of the Association of Pacific Islands Legislatures at Pago Pago, American Samoa, and for other purposes.

Be it enacted by the Legislature of Truk State.

1 Section 1. The sum of \$30,000, or so much thereof as may be necessary, is
2 appropriated from the General Fund of the State for the purpose of funding
3 participation of the Legislature of Truk State at the conference of the Association
4 of Pacific Islands Legislatures at Pago Pago, American Samoa.


5 Section 2. The sum appropriated by Section 1 shall be administered by and
6 is allotted to the Speaker who shall be responsible for ensuring that these funds
7 are used only for the purpose(s) specified in Section 1, and in accordance with
8 the State Financial Management Act, and that no obligations are incurred in excess
9 of the sum appropriated. Any part of this appropriation not obligated as of
10 September 30, 1988, shall revert to the General Fund of the State.


11 Section 3. The Speaker shall submit a report to the Legislature before
12 September 15, 1988, which shall:

13 (1) provide for the full disclosure of the obligations incurred against the
14 appropriated by Section 1, and indicate the status of these funds as of September
15 1, 1988, and


16 (2) indicate the planned use, during the remainder of the fiscal year
17 of funds not obligated as of September 1, 1988, provided that a supplemental
18 report covering the actual use and obligation of the funds shall be submitted
19 to the Legislature or an appropriate committee thereof within 20 days after the
20 closing of the fiscal year.

21 Section 4. This Act shall take effect upon approval by the Governor, or
22 upon its becoming law without such approval.
