15 repwe finita me ren ewe Kepina fiti kapunguno seni ewe Truk State Legislature,
16 me fomon (4) repwe kefinita me ren ewe Speaker-un ewe Truk State
17 Legislature. Me nein ekkewe tiwemon (9) repwe kefinita me ren Kepina me
18 Speaker, nimmon (5) repwe seni pekin business ar angang mei pwan kuu pekin
19 tourist, nge fomon (4) repwe kefinita seni chok aramasen Truk State. Ewe
20 Director-un ewe Putaen Resources me Development non Chuuk epwe i technical
21 staff ngeni ewe Board tori an a kefinita ewe Executive Director non ewe
22 Bureau me ren ewe Board.

3 tonong non Chuuk;

4 8) Epwe study-ini me kutta met ekkewe an tourists needs me
5 pwan facilities;

6 9) Epwe recommend-ini me tungor fonu ika neni ren tourist
7 sites ika facilities;

8 10) Epwe aninisioch ngeni mwiichen me kumiin private me
9 organizations;

10 11) Epwe coordinate-ini sakkun angangen pekin tourist ngeni
11 meni departments, agencies non ewe state government me pwan municipal
12 governments;

13 12) Epwe kuta me awora sakkun chon angang non pekin technical
14 service me pwan sakkun chon angang ika staff mei mefi pwe mei namot ren
15 angangen ewe Bureau;

16 13) Epwe nochchei an epwe chooni met tourist organization non
17 fonufan ika kinikinin non fonufan ika neni me neni mei asenipato fefeitan

 6 eochnoon ewe Bureau.




10 1) Meinisin supplies, records, statistics, brochures, maps,
