A BILL FOR AN ACT

To appropriate the sum of \$3,402.71 from the Revenue Fund of the Kosrae State Treasury to provide funding for the State Liberation Day celebration in each of the municipalities including Walung; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$3,402.71 is hereby appropriated from the

2 Revenue Fund of the Kosrae State Treasury for the purpose of assisting the Municipal

Governments in celebrating the State Liberation Day observation.

Section 2. Apportionment. The sum of \$3,402.71 is hereby apportioned as follows:

(1) Tafunsak/Walung \$1,100

(2) Lelu \$1,100

(3) Malem \$500

8 (4) Utwe \$702.71

Section 3. Allottee. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws. The allottee of the fund appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act and that no obligations are incurred in excess of the sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2011.
