### A BILL FOR ACT

To appropriate the amount of \$1,000.00 from the Revenue Fund of the Kosrae State Treasury to fund special election in Tafunsak Municipality; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. <u>Appropriation</u>. The sum of \$1,000.00 is hereby appropriated from the Revenue Fund of the Kosrae State Treasury to fund the special election for Tafunsak Municipality to fill a vacancy for at large representative of the third hamlet of Tafunsak Municipal Council.

Section 2. <u>Allottee</u>. All funds appropriated by this act shall be allotted, managed,

Section 2. Allottee. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws. The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated and that no obligations are incurred in excess of the sum appropriated.

Section 3. <u>Effective Date</u>. This act shall become law upon approval by the Governor or upon its becoming law without such approval.
