



A BILL FOR AN ACT

To amend Sections 1 and 2 of State Law No. 10-91 to appropriate \$24,763 of supplemental funding for fiscal year ending September 30, 2014; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Section 1 of State Law No. 10-91 is hereby amended to read as follows:
2 “Section 1. Appropriation. Operation of the Executive. To appropriate the sum
3 of \$9,738,752 from the Amended Compact Fund; the sum of \$1,958,122 from the State Revenue
4 Fund; the sum of \$1,017,707 from the United States Grant Fund; and the sum of \$183,000 from
5 the Foreign Assistance Fund of the Kosrae State Treasury for the fiscal year ending September
6 30, 2014, for the purpose of funding the operations of all branches of the Kosrae State
7 Government, its agencies, and various program.

8 Section 2. Amendment. Section 2(18) of State Law No. 10-91 is hereby amended to
9 read as follows:


