A BILL FOR AN ACT

To appropriate the sum of \$48,536 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects and programs in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$48,536 is hereby appropriated from the Foreign  
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects and  
3 programs in the State of Kosrae.

4 Section 2. Apportionment. The sum appropriated by Section 1 of this act is hereby  
5 apportioned as follows:

- 6 1. Kosrae UNHSI Program.....\$1,832  
7 2. Kosrae SPF SIG KYDA.....\$31,507  
8 3. Kosrae owed amount to FEMA.....\$15,197

9 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
10 administered and accounted for in accordance with applicable laws. The allottee of the funds  
11 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring  
12 that these funds, or so much thereof as may be necessary, are used for the purpose for which are  
13 appropriated and that no obligations are incurred in excess of the sum appropriated.

14 Section 4. Effective Date. This act shall become law upon approval by the Governor or  
15 upon its becoming law without such approval.


