A BILL FOR AN ACT

To further amend Section 10.205 of Title 10 of the Kosrae State Code, as amended by S.L. Nos. 8-46, 8-234, 8-17, 9-15, 9-63, 9-81, 9-140 and 10-66, by repealing subsection (c) in its entirety and re-alphabetizing subsections of Section 10.205 to reflect new sequence; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to remove the Airport Trust Fund created
2 for the operation of the Kosrae Airport that is nonexistent in the revolving account of the State
3 Government.

4 Section 2. Amendment. Section 10.205 of Title 10 of the Kosrae State Code, as
5 amended by S. L. Nos. 8-46, 8-234, 8-17, 9-15, 9-63, 9-81, 9-140 and 10-66, is hereby further
6 amended to read as follows:

7 “Section 10.205. The Revenue Fund.

8 (1) The Revenue Fund contains all monies received by the Government
9 pursuant to a law imposing a tax, duty or tariff, and all other revenues and reimbursements from
10 a fine, fee, license, interest, rent, or Government service, and other Government collection or
11 collections by a government for the Government's benefit except as otherwise required by law. A
12 person who receives monies pursuant to this section transmits the monies within seven days of
13 receipt to the Division of Finance and Budget for deposit in the Revenue Fund except that:

14 ...

15 (c) The Division of Finance and Budget retains in a Recycling Fund all
16 monies collected pursuant to Title 9, Chapter 22, and follows the Recycling Program Regulations

1 for the disbursement of Recycling Fund monies for the refund of Recycling Deposit fees, and
2 the maintenance of a recycling program;

3 (d) The Kosrae's Visitors' Bureau may retain monies received from the
4 sale of books, postcards, handicrafts, and other tourist material for the purpose of acquiring
5 additional inventory of such classes of items; and

6 (e) The Division of Finance and Budget retains in a Publication Fund
7 the proceeds received from the sale of copies of the Kosrae State Code and the Selected Laws of
8 the State of Kosrae, which proceeds are available for use by the Code Revision and Publication
9 Commission to defray the costs of preparation and publication of the Selected Laws of the State
10 of Kosrae;

11 (f) The Division of Finance and Budget retains in a Health Care Fund
12 all monies collected from or on behalf of patients or clients or the Kosrae Department of the
13 Health Services, including, but not limited to, reimbursements from any program of medical
14 insurance and payments received by the State in connection with off-island referrals. Monies in
15 the Health Care Fund are continually appropriated for expenditures by the Department of Health
16 Services solely for the purchase of medical supplies, inclusive of pharmaceutical supplies, for
17 use by the Department of Health Services, its clinics, dispensaries, programs, patients and for
18 advancing payment of employees' salaries and benefits, when those salaries and benefits have
19 been authorized for reimbursement by the Federated States of Micronesia National Government;
20 provided, however, that the funds received as reimbursement shall be deposited in the Health
21 Care Fund.

- 1 (g) The Division of Finance and Budget retains in a State Scholarship
2 Grant and Loan Fund, all monies received from Kosrae State Government appropriations for
3 scholarship purposes and from loan collection from student loans. Monies in the Scholarship
4 Fund must be made available solely for Kosrae State Scholarship Board and continually loaned
5 out to qualified recipients.
- 6 (h) The Division of Finance and Budget retains in a Broadcast Authority
7 Fund all monies from payments received from advertisements and other broadcasting programs
8 requiring payments to the State Broadcast Authority. Monies in the Broadcast Authority Fund
9 are available solely for the purpose of funding operations of the State Broadcast Authority;
- 10 (i) The Department of Education retains in a Yearbook Revolving Fund
11 all monies contributed, received and collected from yearbook sales by depositing that revenue
12 into the fund using it strictly for the Kosrae high School yearbook; and
- 13 (j) The Department of Resources and Economic Affairs may retain
14 monies collected or received under its housing loan program in the Kosrae Home Improvement
15 Program Revolving Fund, and promulgates regulations and guidelines for the disbursement of
16 said monies;
- 17 (k) The Division of Finance and Budget retains in a Department of
18 Transportation and Infrastructure Fund all monies collected from contract and grant projects, for
19 the purpose of purchasing fuel and materials necessary to mobilize and accomplish contracted
20 work including, but not limited to, reimbursement received by the State in connection with
21 contract and grant projects. Any monies received that is in excess of the cost of fuel and

1 materials shall, at the conclusion of the specific contract, be transmitted to the General Revenue
2 Fund. This account may also receive funds from the sale or auction of equipment. Any such
3 funds may be used solely for the repair and replacement of Department equipment and the
4 purchase of fuel necessary for Department work projects; and
5 Each department, office, and agency retaining monies pursuant to subsections (a) through
6 (k) provides a written monthly report to the Governor and the Speaker on the status of the
7 monies, including amounts received and expended; upon determining that a department, office,
8 or agency has money in excess of the amount necessary for the purpose for which it is allowed to
9 retain the funds, the Governor directs that said excess be turned over to the State Treasury.

10 (l) The Court may retain monies received as payment for published
11 decisions, opinions, rules, or probation fees or other documents issued by the Court.

12 Section 2. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
